



# Pigment Concentrate 668

For tinting or shading wooden or mural surfaces.

**Application range:**

Even a small addition of the LEINOS 668 pigment concentrate has a very high colouring power. Pigment concentrate 668 cannot be used alone as the only colouring agent. Pearl lustre pigments can only be used for LEINOS 646 Glaze Binder.
